

# Customs Declaration for Independent Switches EML



## Article Overview

To import or export independent switches (EML) into the EU, a customs declaration must be submitted online with accurate HS codes, EORI number, and detailed shipment information, either by the company itself or via a representative.

### Key Requirements

1. Customs Declaration: A customs declaration is an official document detailing goods being imported or exported into the EU. It is required to place goods under an EU customs procedure, such as the export procedure for shipments leaving the EU or import procedure for goods entering the EU customs territory (Union Customs Code, Articles 5, 158-187) . 2. HS Code and Product Description: Independent switches (EML) must be classified with at least a 6-digit HS code and a detailed description of the goods. General product names are insufficient; the description should clearly identify the type, function, and technical specifications of the switches . 3. EORI Number: Companies must have an Economic Operator Registration and Identification (EORI) number to submit customs declarations. This number is mandatory for both import and export filings within the EU . 4. ICS2 Compliance: For shipments entering the EU, Norway, Switzerland, or Northern Ireland, the Import Control System 2 (ICS2) requires an Entry Summary Declaration (ENS) before arrival. This includes buyer and seller information, shipment details, and any associated House Bill numbers . 5. Submission Options:

- Self-filing: Companies can submit the declaration themselves if authorized....
