

New Long-Distance Optical Cable Customs Declaration



Overview

Commission Implementing Regulation (EU) 2024/3014 of 13 December 2024 imposing a definitive anti-dumping duty and definitively collecting the provisional duty imposed on imports of optical fibre cables originating in India (OJ L, 2024/3014, 16). The measure applies to cables consisting of one or more individually sheathed fibres, with protective casing. The merchandise under consideration is described as optical fiber cable, which is identified by the model number MTP®/MPO Trunks-48FMTPSMF. The cable is further described as double-jacketed trunk cable patch cord assembly. Each shipment must be accompanied by a specific document package that satisfies three different stakeholders: the customs authority, the end customer's quality.
